TERMS:

1. General

- a. The services to be rendered by the Vendor are for the sale of alcoholic beverages and food at the Barony's Anniversary Event occurring October 9th and 10th, 2026.
- b. The total fee to be paid to the Vendor by the Barony, including any deductions or applicable taxes, is three hundred and fifty Canadian dollars (\$350).
- c. All business pursuant to the terms of this agreement will be conducted on behalf of the Barony by their designated Event Steward, subject to applicable regulations and bylaws of the Barony.
- d. The Vendor will purchase and acquire all materials and human resource required for sales at the event.
- e. The Vendor may advertise sales and solicit assistance on Barony social media, subject to all Barony policies and review by Barony officers.

2. Liability and Permit

- a. The Vendor will assist the Barony and Event Steward in securing a sale permit for alcohol subject to the applicable laws and regulations.
 - i. The Barony will be the primary holder of this permit and, in doing so, assume liability under the terms of that permit.
- b. The Vendor will indemnify and hold harmless the Barony and Event Steward for any damages or losses incurred in executing this agreement outside the liability described in the sale permit.
- c. Conduct of the Vendor in executing the terms of this agreement will otherwise be in accordance with the guidelines, policies, and expectations of the Barony for their members.

3. Payment

- a. Payment will be issued to the Vendor within 15 business days of the signing of

this agreement, subject to applicable terms and policies.

- b. The Barony will not dispense any further funds beyond the fee for this agreement, including wages or initial purchase of alcohol for resale.

4. Term of Agreement

- a. This agreement comes into effect on the latest date of signing between the authorities listed below and shall be in effect until October 11th, 2026, unless it is terminated pursuant to the other terms of this agreement.

5. Severability

- a. If this agreement is terminated for any reason prior to the delivery of service at the event, the full amount of the fees paid to the Vendor will be returned within 14 days of notice of termination.
- b. This agreement can be severed and terminated by either party at any time by written or digitally-delivered notice to the Event Steward 48 hours in advance of the intended time of termination.
- c. If either party is found to be in violation of the terms of this agreement, Barony policy, or applicable laws and regulations, the Barony may terminate this agreement with immediate effect via written notice delivered by digital means.
